Theft F/Auto = Theft from Auto (Car Break-ins)

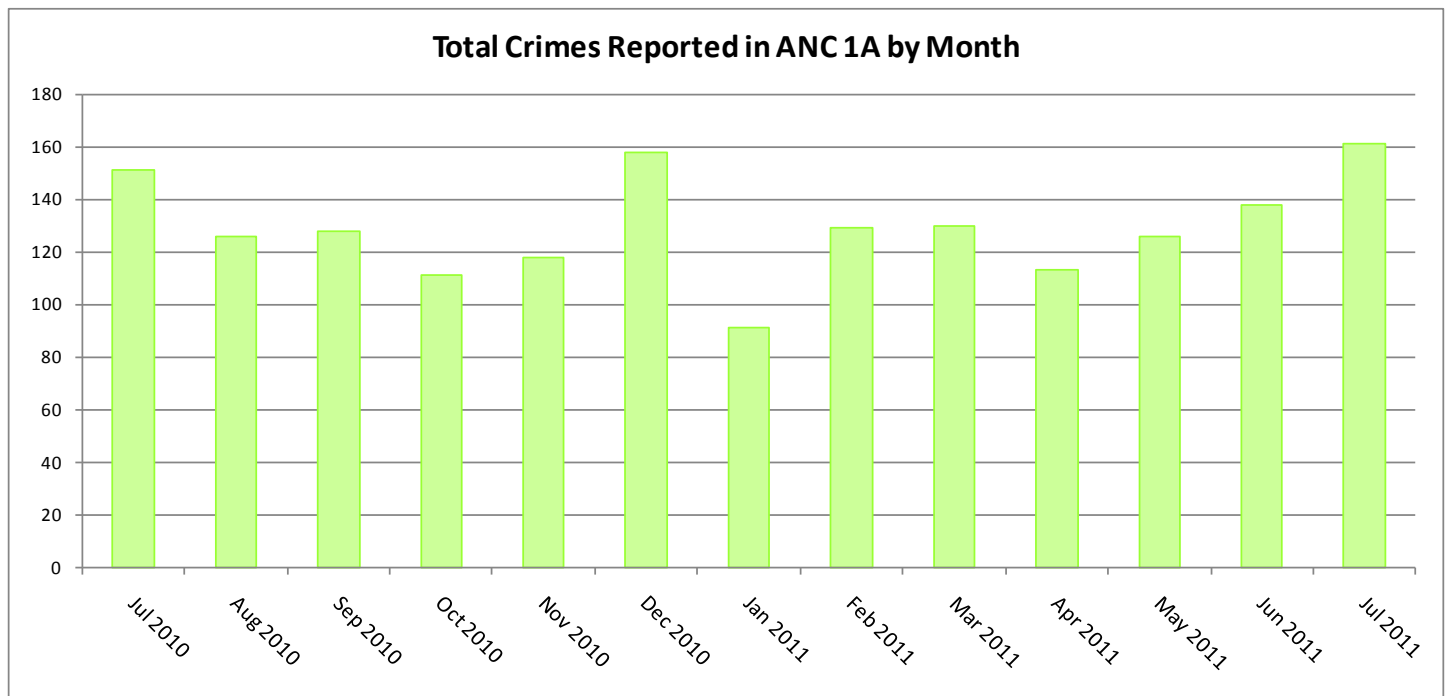
Robbery:

### **Key to Case Information Shown in the Table:**

Column Heading	Description
DCSC Case No.	DC Superior Court case number. Find case information online at <a href="https://www.dccourts.gov/cco/maincase.jsf">https://www.dccourts.gov/cco/maincase.jsf</a>
Defendant's Name	Name of the defendant who has pled guilty/was found guilty of the charge.
Charge	Charge #1 for which the defendant is being sentenced. There may be additional charges.
Location of Offense	Address where the offense occurred. The address could be the block, the approximate address of the crime, where the suspect was arrested, where a warrant was served, or the police station/courthouse.
Sentenced	Date the defendant was sentenced by the judge.
Results	The amount of jail time the defendant was sentenced to serve. Notation: X/Y: "Y" is the sentence, and "X" is the portion that was not suspended—how much time the defendant will actually serve. For example, "0/9 Mos" is a nine-month sentence with all of it suspended. YRA = Youth Rehabilitation Act.
Age	The defendant's age. When young defendants are convicted of a felony but have only 1 or 2 adult cases, they may already be chronic repeat offenders in the juvenile system.
No of Cases	The number of defendant's papered arrests shown in the DC Superior Court's Online system. UNK=Unknown: When defendant's names are too common, it's not easy to tell how many cases are actually theirs and not someone else's.
